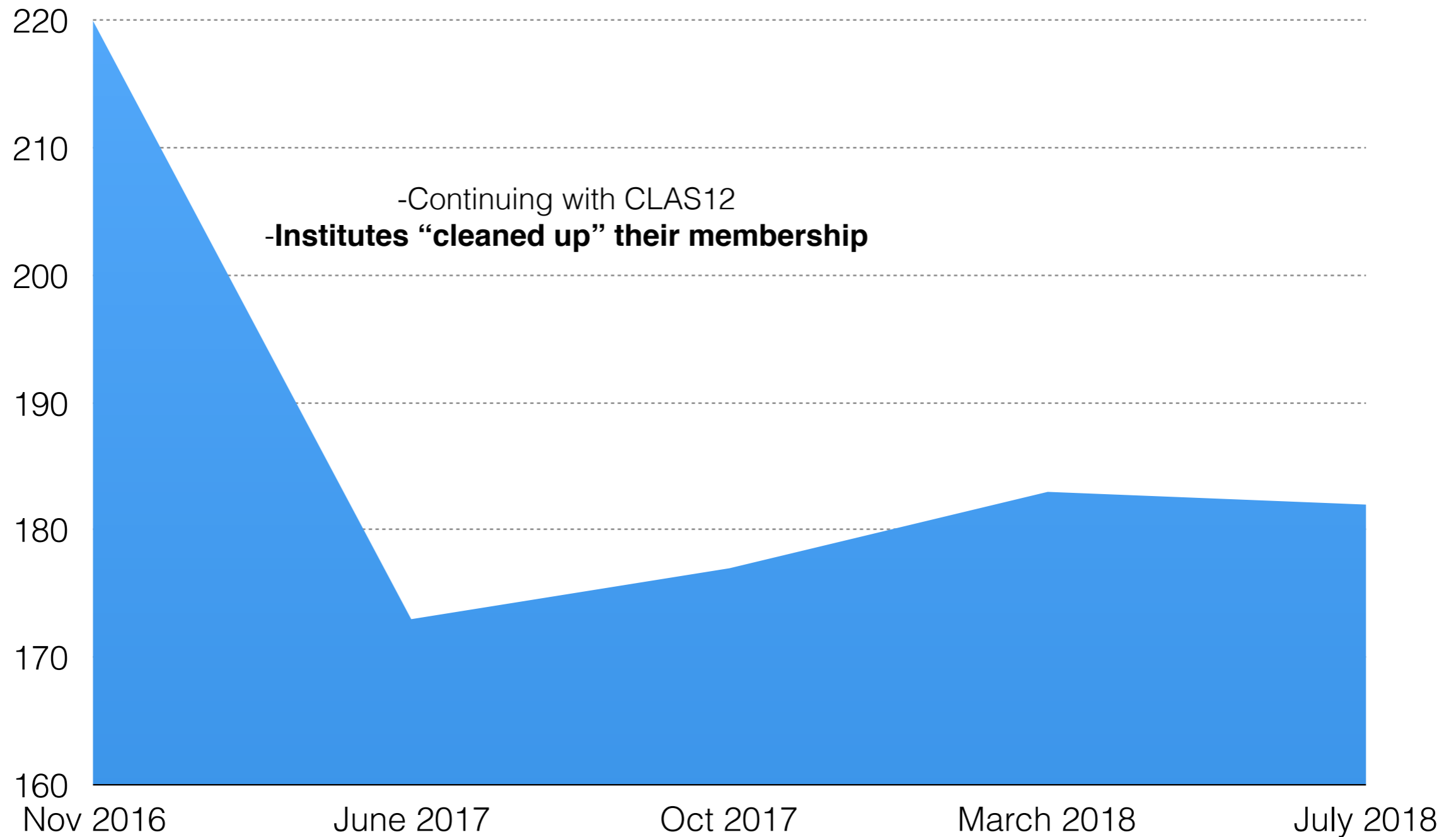

Unusual shift schedule accounting for reward

- causing some issues

“When a part of the CLAS or CLAS12 activity is to become the thesis work of a student, the student’s thesis advisor will so inform the Chairperson of the Coordinating Committee in writing. The Chairperson, or a delegate, will maintain a list of active thesis projects.”

-CCC need to know and be allowed to ensure no duplications or significant overlaps

-Having a listing on the thesis project website is not enough

-CLAS/CLAS12 PhD students should (MUST) be CLAS members when they start. Not 1, 2, 3.....yeas in to their studies or worse when they finish.
