1. Cause (Address Variances Individually)

SV: In 1.8.2.4.3 (SV=-\$196k) a number of the online tasks have been reorganized and generally reduced in the ETC (ReBaseline). No work is carried out on these tasks. 1.8.2.4.4 the CTP production (and its testing) is ongoing but not complete, because several boards had to be returned to the vendor for repairs under warranty. The original Baseline schedule had trigger devices and software checkout being done under 1.8.2.4. This is re-organized in the ReBaseline and should not have started under that schedule, which reflects the actuality of in particular the DAQ and Online software. This situation will not materially change until mid-FY2014

2. Proposed Solutions (Corrective Actions)

SV No work will continue on the tasks in 1.8.2.4.3 (removed in the ETC). The 1.8.2.4.4.3 will be resolved in Sept-Oct 2013 (the CTPs arrive in August-Sept). The 1.8.2.4.4.6 production was delayed in the ETC till November.

Estimated Resolution By (Date): 15 September 2013 for 1.8.2.4.4. The SV in 1.8.2.4.3 will be reset with the ReBaseline 1.8.2.4.4 - November 2013
