1. Cause (Address Variances Individually)

SV: Beam position monitors are late relative to the baseline plan (475k\$). The nA BPM system was moved to FY14 (382k\$). The balance is due to delays fabricating the electronics for the Hall D BPM system (93k\$). Harp installation is was delayed as we wait for beamline to be installed (17k\$). The Fast Feedback System was moved to FY14 (146k\$).

CV: Activities 13611014B, 13611025b, 13611026b, 13611075, 13612025, 13612030, 13612035, 13613025, 13613030 are all "H" activities related to the installation and testing of BPMs, Harps and Viewers. This totals to 130k\$ of EV that we will claim as the work is completed.
